PUBLIC COMMENTS:

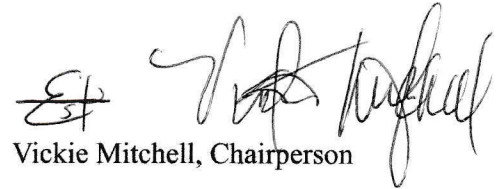
