- a) **#UDO 26-01 – Consideration and Recommendation on a text amendment to the text of The Unified Development Ordinance for the City of Snellville, Georgia (“UDO”). The proposed amendment is to Chapter 100, Article 1 (Introductory Provisions; Article 2 (Definitions); and Article 3 (Administration) and to Chapter 200, Article 1 (Rules for All Zoning Districts); Article 2 (Residential Districts); Article 6 (Use Provisions); and Article 7 (Site Development).**

Planning Director Jason Thompson gave a report on the proposed changes to the UDO and added a last minute change. Vehicle Rental was found to be duplicated in Chapter 200 Article 6. The duplication would be removed and the existing definitions and use provisions would be adjusted.

Chairman Kori opened the meeting to public comment.

Tricia Rawlins, 2088 Harbour Oaks Drive, came forward with questions regarding group homes within the city limits.

Chairman Kori closed the meeting to public comment and asked for a motion.

Rose Purdy made a motion to approve UDO 26-01 as presented by staff.
